# ISO 14001 explained

# What is **ISO 14001?**

# ISO frameworks are a set of internationally recognised guides and processes for organisations to use.

The ISO 14000 family of standards exist to help companies manage their operations so that they have minimal effect on the environment, alongside ensuring compliance with relevant laws and regulations, and maintaining continuous improvement.

ISO 14001 provides a framework for organisations to follow that enables them to develop, implement, and maintain an effective environmental management system.

The guidance covers various areas of business operations, including procurement, storage, distribution, product development, manufacturing, and more. The goal is to mitigate or reduce any negative environmental impact at every stage in the life cycle of a product or service. Crisis situations, stakeholder expectations, and the effect the business has on any local communities are also included.

This certification evidences that you're serious about sustainability — something that every reputable organisation should be committed to in the fight against climate change and pollution. More often, ISO 14001 is being required as standard, as companies look to ensure that their supply chain meets certain sustainability criteria.

# What is **required?**

The aim of ISO 14001 is to take responsibility for the impact business operations have on the environment. When in use, the EMS has three intended outcomes: to help with the understanding of a company's environmental impact, to ensure compliance with local, regional, and national regulations, and to reduce environmental impact through the use of effective processes and controls.

The requirements of ISO 14001 consist of 10 clauses, of which the first three only describe the standard. Clauses 4 through to 10 contain the elements of the environmental management system, and include:

### **Context of the Organisation**

This section includes the general requirements for an environmental management system, including the needs of all relevant stakeholders, as well as the scope of the EMS — taking into account all of the consequences and effects that it will have internally, externally, and environmentally.



### Leadership

Senior leadership must identify organisational roles, responsibilities, and authorities that will be included in the EMS. This requirement also includes the definition of the environmental policy, which covers the environmental objectives and compliance with legal requirements. This must come from top management as a directive to ensure it becomes embedded in company culture.



#### Planning

Planning for and identifying risks is central to any ISO certification. For ISO 14001, this involves the evaluation of environmental aspects, i.e. how operations interact with the environment, and addressing their impact. This is integral to the EMS.



### Support

The support requirement is the largest section, and addresses the allocation of resources to the EMS. It also covers requirements around the competence of staff, awareness of the EMS across the business, good communication, and the effective control of documented information. Training of staff is crucial to the success of the environmental management system.

# What is **required?** (continued...)



#### Operation

This requirement stipulates that an organisation develops a plan that ensures it takes full operational responsibility for its environmental impact, and takes every step to manage and control it. The main outcome of implementing an EMS is the reduction and/or mitigation of any environmental impact and therefore, this clause is critical.

#### **Performance Evaluation**

It's mandatory to carry out internal audits, and that the audit system itself is able to quickly highlight any issues that need resolving. This is an effective way to monitor, measure, and analyse the outcomes of your processes, and senior management should develop a method to regularly review results.



#### Improvement

This clause addresses how you will manage any nonconformities in any EMS processes, including what corrective actions you will take once they're identified. This section also includes methods for continuous improvement through constantly working towards lessening your environmental impact.

# Achieving ISO 14001 status in 5 easy steps

### **Step 1:** Develop the ISO 14001 environmental management system

During this step, an internal audit is completed to ensure that the processes in the EMS are aligned with the environmental objectives, and to discover if there are any problems within the processes themselves that need to be resolved.

A management review will then take place to ensure resources are allocated correctly, and that any corrective actions required will take place.

### **Step 2:** Appoint a UKAS accredited certification body

A UKAS accredited body is guaranteed to be impartial, and is the gold standard for certifying bodies in the UK. This is because it has proven it complies with best practice, and will deliver a competent and impartial service based on internationally recognised standards.

### **Step 3:** Prepare for your Stage 1 audit

Before the stage 1 audit, businesses must complete a final review of their EMS to ensure that no vital information has been missed, cross-referencing against the standards laid out in ISO 14001. During this preparation stage, it's important to ensure staff are trained and up to speed, as competence in updating documents is key to an effective EMS — and to passing audits.

### **Step 4:** Complete Stage 1 and Stage 2 audits

An auditor from a UKAS accredited certification body will attend the site that is undergoing ISO 14001 implementation to carry out each audit.

#### • Stage 1 audit:

The auditor will check that your documentation meets the requirements of ISO 14001, and gauge the organisation's readiness for the stage 2 certification audit, identifying areas where you're not currently meeting the standard so that changes can be made before the next stage.

#### • Stage 2 audit:

The auditor will then return for the stage 2 audit, meticulously going

through all the documentation and looking to see that feedback from the stage 1 audit has been acted upon. If this audit is a success, your business will receive ISO 14001:2015 certification — congratulations!

### **Step 5:** Continually review the ISO 14001 EMS for its annual audit

An auditor from the UKAS accredited certified body will return every year to re-assess certification — as long as the environmental management system (EMS) continues to meet the requirements of the ISO 14001 standard, ensuring that your business continues to take responsibility for the environmental aspects of its operations.
