A specialist personal protective equipment (PPE) company, its strapline is 'Saving Lives' – and while they are compliant in everything they do, they lacked a real system to prove it.

Skanwear partnered with our team in the implementation of four ISOs, the first being 9001. Putting their trust in us again to integrate ISO 14001 and ISO 45001 with their current ISO 9001, they also sought our support to gain ISO 27001 certification.

THE CHALLENGE

The company knew that being certified to the right ISO standards would help them become more organised day-to-day.

For Skanwear, it was also about demonstrating that they look after their own staff as well as their customers.

While the company was proud it hadn't suffered any data breaches, the team wanted to ensure its data was as safe and secure as possible, with a robust mechanism in place. This, in turn, would improve customer confidence.

Having an equivalent non-UKAS ISO 9001 certification in place – which, unfortunately, did not add value to the business and hadn't undergone inspection by anyone

externally – Skanwear benefited from our expertise from the off to gain the appropriate UKAS certifications.

Liam went on to say that "As a business, we were conducting health and safety practices, but we were not documenting evidence of this." said Liam. "We didn't have a training matrix in place and, as a result, found it difficult to monitor training gaps in the business and refresher due dates."

Liam hoped that, thanks to the right UKAS ISO standards, Skanwear could further boost its credibility and ensure business tendering is even simpler and faster. He added: "ISO systems allows us to fully evidence what is working well and where we need to make further improvements."

THE RESULTS

Before contacting our team here at Synergos Consultancy, Liam researched ISO standards online.


